- Higher Education institutions
- Non-profit organisation and Public Benefit Organisations

The workshop will cover:

- The basics requirements of the legislation
- Highlight areas to focus on to ensure compliance
- Provide a detailed description of evidence required for a verification
- A B-BBEE scorecard calculator tool will also be introduced to delegates to assist with B-BBEE strategy and monitoring on and on-going basis.
